Speakers' Profile

Mr. William Leung

Mr. Leung is currently Executive Director and Group Deputy Chief Executive Officer of Sun Hung Kai & Co. Limited, a wealth management company founded in 1969 and listed on The Stock Exchange of Hong Kong Limited (Stock code: 86). Concurrently, Mr. Leung is Executive Director and Chief Executive Officer of Sun Hung Kai Financial Limited, a subsidiary of Sun Hung Kai & Co. Limited.

Mr. Leung has more than 30 years of management experience in the finance and banking sector. He has held key positions in major financial institutions in Hong Kong and Australia, which include American Express International Inc., Standard Chartered Bank, Visa International, MasterCard International, and Hang Seng Bank. Prior to his current appointment, he spent seventeen years at Hang Seng Bank and was promoted from Assistant General Manager level to Executive Director. In his last position in Hang Seng Bank, he was responsible for its Personal Banking and Wealth Management business.

Born and raised in Hong Kong, Mr. Leung graduated from the Hong Kong Baptist College in 1978 and received a Diploma in English Language and Literature. He was elected Honorary Certified Financial Management Planner ("CFMP") of the Hong Kong Institute of Bankers in 2006. Hong Kong Baptist University conferred him the title of Honorary University Fellow in Sept 2013 and awarded him the Distinguished Alumni Award in March 2014.

Mr. Leung is active in community services. He is Chairman of Employees Retraining Board, Chairman of the Council of the Hong Kong Academy for Performing Arts, Chairman of the Hong Kong Baptist University School of Business Advisory Committee, Chairman of Hong Kong Creative Arts Centre Limited, Chairman of Estate Agent Authority, Vice Chairman of The Hong Kong Heart Foundation Limited, a member of Digital 21 Strategy Advisory Committee, a member of the Joint Committee on Student Finance, a Co-opted member of the Commission on Poverty (Youth Education, Employment and Training Task Force), a member of the Consultation Panel of the West Kowloon Cultural District Authority, a member of Manpower Development Committee, a member of the Task Force on Promotion of Vocational Education and a member of the Advisory Board of Yan Oi Tong, apart from a number of other public services.

Mr. Leung used to be the Board Chairman of Hong Kong Dance Company from 2005-2009 and Treasurer of Council of the Hong Kong Baptist University from 2007-2014.

Mr. Leung was appointed Justice of the Peace on 1 July 2005 and honoured with a Bronze Bauhinia Star on 1 July 2009 by the HKSAR Government.

Mr. James S. Tsien

James Tsien has been appointed Senior Adviser of Hutchison Port Holdings Limited (HPH) from January 2014. He was formerly the Group Executive Director of HPH and the Managing Director of Hutchison Ports China Limited. During his tenure as a top line executive at HPH, he served concurrently as HPH's Chief Financial Officer in charge of finance, corporate administration, information technology, legal and company secretarial functions. He was appointed to the boards of HPH (in 1996) and over 280 HPH group companies in 35 countries. His role as the Chief Executive of Hutchison Ports China Limited included 12 ports and 16 operating companies, two of which he served as Chairman. He also served as a director of Hong Kong Air Cargo Terminals Limited (Hactl) from 1996 to 2013. He joined Hong Kong International Terminals Limited (HIT) as General Manager - Finance in March 1994.

Mr. Tsien joined HIT from Citibank, N.A., New York where he last served as Vice President and Director of Investment Management Services. He joined the then First National City Bank as an Executive Trainee in 1973, and in his 20+ years with Citibank, Mr. Tsien assumed a wide variety of senior management positions in all three of the bank's core businesses (corporate, investment and consumer) in Asia, Europe, Latin America and North America.

Mr. Tsien graduated with distinction in business management and economics from Hong Kong Baptist College in 1973. He went on to study international management at the Graduate School of Business at Columbia University, New York in 1981. Mr. Tsien is a fellow of the Chartered Management Institute, England and a member of the Chartered Institute of Bankers, England and Hong Kong.

He was appointed to the Court of the Hong Kong Baptist University from 2005 to 2011, granted Honorary Fellow in 2010, and also served as the Chairman of the School of Business Advisory Committee from 2003 to 2013. He also served on the Corporate & Employee Contribution Committee of the Community Chest of Hong Kong.

He and his wife, the former Teresa B.K. Wong, have a son and a daughter, and live in the New Territories, Hong Kong.
